



ITC Badges

The following badges will be made available to exhibiting companies at ITC. We encourage you to pre-register your exhibitor booth personnel, Installation and Dismantle personnel, company employees not working in the booth and customers who will be invited by your company to visit the exhibits.

All of the following badge categories will be available for online registration, except for the Installation and Dismantle badges. Please see the form located in the Exhibitor Appointed Contractor section of this manual. All of these badges will be available for onsite pickup only at the exhibitor registration desk.

Complimentary Exhibitor Booth Personnel (Employees working the booth)

This badge admits bearer into the exhibit hall during regular and restricted exhibit hours. This badge will also admit the bearer into the Welcoming Reception and Plenary Session, but WILL NOT admit the bearer into the technical sessions.

Exhibiting companies will have a limited number of these complimentary badges for each booth purchased. As an exhibitor of ITC, you are entitled to 5 complimentary exhibitor booth personnel badges plus 5 additional complimentary exhibitor booth personnel badges per each contracted booth. When you login to the online registration form, the form will automatically have these allotments pre-set for your company.

Please note that if a member of your exhibiting staff is also registering and paying for the Conference, it is not necessary to register them as Exhibitor Booth Personnel. Just inform them to stop by the exhibitor registration desk on-site to have their paid conference badge validated to include unrestricted admission into the exhibit hall.

Paid Exhibitor Booth Personnel (Employees working the booth)

This badge will be available for a cost of \$50 for exhibitors who have exceeded their Complimentary Exhibitor Booth Personnel allotment and have the same function as the Complimentary Exhibitor Booth Personnel above.

Complimentary Conference

As an exhibitor of ITC, each company will receive two Full Conference Registrations. These badges WILL NOT admit bearer into the exhibit hall during restricted hours and are not a substitute for an Exhibitor Booth Personnel badge. These badges will include the exhibiting company name only, so that may be passed between individuals from your company who may wish attend the technical sessions of their choice. This complimentary badge also includes a copy of the current proceedings and which must be picked up and signed for at the Exhibitor Registration Area.

Installation and Dismantle

This badge should be used for your exhibit house, EAC (Exhibitor Appointed Contractor), or any other individual who will not be required in the booth during exhibit hours. These badges are restricted to set-up/dismantle only and will not be allowed access to the exhibit hall during regular exhibit hours. There is no cost or limit to these badges.

Complimentary Exhibits Only (Customers of exhibiting company)

This badge is intended for non-conference attendees invited by your company, and will admit the bearer into the exhibits during regular exhibit hours. This badge does NOT admit the bearer into Technical Sessions, Welcoming Reception and Plenary Session and DOES NOT include ITC promotional or technical material. Each Exhibiting company has an allotment of 5 of these badges. As with all ITC attendee badges, the name and contact information must be provided at the time of registration.

Paid Exhibits Only Badge (Customers of exhibiting company)

This badge will be available for a cost of \$50 and is intended for non-conference attendees invited by your company and has the same limitations as the Complimentary Exhibits Only badges above.
